Inner seal for water lubricated stern tube composed of: (from inside to outside)

- One mating ring with polished contact surface. Material Stainless steel or brass. The mating ring is bolted on the stationary casing.

- One (EVK) / Two (EVK2RT) seal rings made of rubber material NBR. The rings are locked on the propeller shaft sleeve by a torispherical spring.

- One emergency inflatable ring

SIZE: Diameter of the propeller shaft, from 50 to 690 mm (EVK), 110 to 690 (EVK2RT).
